Teams compete to see who can pull the truck the fastest, raise the most money, and show us their team spirit through creative costumes and team energy!

Anyone can put together a team. Grab up to 9 of your friends, register, raise \$1000 (that's just \$100 / team member) and you are on your way to being Cornwall's Strongest Team!

Team Requirements:

1. Maximum of 10 participants per team.
2. Each participant must be a minimum of 13 years of age.
3. Each team **MUST** have a TEAM NAME.
4. Team captains must **submit Team Contact information** to trucktow@beyond21.org **no later than August 12, 2019**
5. **Team Captains** are responsible for managing the team's fundraising page, including updating totals from group fundraising efforts, and cash or check donations made to any teammate that doesn't have a Personal Fundraising Page. Team Captains must also ensure that all teammates receive a Waiver Form and a Donation form (included in this information package).
6. Each team **MUST raise a MINIMUM of \$500** by the end of Team Check-In in order to be guaranteed the opportunity to pull the Pumper Truck. **On a 10-person team this is an average of \$50 / person.** Team members can divide up the fundraising amount between team members as they see fit as long as the team goal is achieved.
7. All donations **are final** regardless of the team's total.
8. All teammates are responsible for completing the Donation Forms by collecting the required information from cash and check donors. Cash and check donations of \$25 or more are able to receive a charitable tax receipt.
9. On event day all teams must report to the Team Check in at Bicycle World **NO LATER THAN 1:30 PM** and bring the following:
 - a. All donated funds (cash and check)
 - b. Individual signed waiver forms from each team member (see pages 7-8 in this package)
 - c. Team Fund Tracking Sheet (see page 6 in this package)
 - d. Any Donation Forms the teammates used (see page 9 in this package)
 - e. The Team Bio form (see page 5 in this package)

Waiver FORM

RELEASE OF LIABILITY WAIVER CLAIMS, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, CORNWALL TRUCK TOW, 2019

Each team member must fill in this form individually

By signing this legal document, you will be giving up certain legal rights, including the right to sue or claim compensation following an accident. Please review before signing.

DEFINITION:

In this legally binding Release of Liability, Waiver Claims, Assumption of Risk and Indemnity Agreement (hereinafter referred to as the "Release of Agreement") the term "Activity" shall include all activities or services provided, arranged, organized, conducted, sponsored, or authorized by the Releasees related in any way to and/or during the Cornwall Truck Tow.

ASSUMPTION OF RISKS:

In consideration of participating in the Cornwall Truck Tow, I declare that I am aware of and understand the nature of the "Activity" and that I agree that I am qualified, in good health, in proper physical condition, and not under the influence of alcohol, marijuana, or any controlled substances. I also agree that if I believe the conditions surrounding the "Activity" are unsafe or if I feel unwell or unfit to safely participate in the "Activity" I will immediately withdraw from participation in the "Activity."

I am aware that participating in "Activity" involves risks, dangers, and hazards. The risk, dangers, and hazards, including but not limited to: slips or falls on pavement, cement, or gravel; physical contact with other people; serious bodily injury including permanent disability, paralysis, and death; all of which may be caused by my own action, accident or inaction, other participants in the "Activity", the conditions in which the "Activity" takes place, or due to my own negligence.

I am aware of the risks, dangers, and hazards associated with the "Activity" and I freely accept and fully assume all such risks, dangers, hazards, as well as the possibility of personal injury, death, property damage, or loss I incur as a result of my participation in the "Activity."

In consideration of the Releasees agreeing to my participation in "Activity," I hereby agree as follows:

1. To waive any and all claims that I have or may have in the future against the Releasees and to release the Releasees from any and all liability for any and all

loss, damage, expense or injury (including death), that I, or my next of kin, may suffer from my participation in the "Activity" due to any cause whatsoever, including Negligence, Breach of Contract, or Breach of any Statutory or other Duty of Care on the part of the resleesees and further including the failure on the part of the releasees to safeguard or protect me form the risks, dangers, and hazards of participating in the "Activity" referred to above:

2. To hold harmless and indemnify the releasees for any and all liability to any property damage, loss, or personal injury due to my participation in the "Activity";
3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns, and representatives in the event of my death or incapacity;
4. To agree to vie my permission for free use of my name, voice, photograph, video film, and any other from not described, for the purpose of advertising, broadcast, social media postings, regarding the "Activity" at any time; and
5. I certify that I am at least 13 years of age or older.

I have read the release agreement and understand that I, or any heirs, next of kin, executors, administrators, and assigns, have given up substantial rights by signing the release agreement, and have signed it freely without any inducement or assurance of any nature, intending it to be a complete and unconditional release of all lability to the greatest extent allowed by the law.
